## **TUBE WARRANTY**

The Carlstar Group LLC ["Carlstar"] warrants, subject to the terms, conditions and limitations stated herein, its Highway/Non- Highway Tubes (tubes) to be free from defects in materials and workmanship.

## 1. THE CARLSTAR WARRANTY ["Warranty"]

applies only to the original purchaser of the tubes and only if they are used in the service for which they are intended. Rear tractor tubes are warranted for a period of five (5) years from date of manufacture. All other tubes are warranted for a period of three (3) years from date if manufacture. All with proof of purchase required.

## 2. WARRANTY COVERAGE

The Warranty is void if the tube fails due to the following conditions:

- Mounting damage, cuts or pinches
- Tubes subjected to road hazards (punctures, cuts, stubble damage, impact, valve pulled from tube, etc)
- Rim/Bead cuts Rim slip
- Overloading the tube/tire beyond the maximum load capacity stated on the sidewall
- Under inflation, fitment to incorrect rim, purposeful abuse or chemical contamination
- Improper insertion of fluids into the tube including any type of flammable liquids
- Any foreign material inside the cavity of the tire
- Repaired tubes
- Tubes used in racing or competition

## 3. LIMITATIONS

Carlstar will reimburse the original purchaser the tube cost, together with reasonable and actual service charges within the limits as explained:

- Replacement costs for wheels or tires are not covered.
- Incidental or consequential damages, including, but not limited to, lost time, inconvenience, loss of vehicle use, cost of towing or transportation, related property damage or consequential damages of any type or nature are not covered
- Replacement of any liquids used in tube are not covered
- For Rear Farm and OTR tubes only, reimbursement will be provided for the cost of a service call. Reimbursement for the service call is limited to actual cost incurred, not to exceed \$70.00.

To obtain warranty adjustments or warranty information contact your Carlstar tire and wheel dealer or call the Customer Care Unit at 1-800-260-7959 or fax to 1-800-352-0075. Claims must be made within 30 days of discovery of irregularity. Carlstar reserves the right to inspect all products before making adjustments.

OTHER THAN AS EXPRESSLY STATED IN THIS WARRANTY, THERE ARE NO WARRANTIES EITHER EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. NO REPRESENTATIVE OF CARLSTAR HAS THE AUTHORITY TO MAKE ANY REPRESENTATIONS OR PROMISES EXCEPT AS STATED HERE.

Some states do not permit limitations on the period of an implied warranty and do not permit the exclusion or limitation of incidental or consequential damages, therefore the above limitations or exclusions may not apply. This warranty provides specific legal rights. Other rights may vary according to the state/province in which the original purchaser is located.
